

# **GLOBAL ECONOMIC SLOWDOWN: THE IMPACT ON MANUFACTURING**

#### **GLOBAL ECONOMIC RECOVERY: SEIZING OPPORTUNITIES FOR GREENING INDUSTRIES**

Participants will identify and build on emerging novel areas for investment and growth, focus on the greening of existing industries, and developing new sustainable green industries. They will discuss a number of conditions that need to be met for greening to underpin long-run growth. These include the emerging opportunities for profitable investments; the need for enhanced interest for environmentally friendly goods and services from the population at large; and making sure that "green and greening industries" are more dynamic, and eventually larger, than "brown and browning industries". Vital international policy coordination to address these requirements, as well as incentives at national levels, will also be discussed.
